

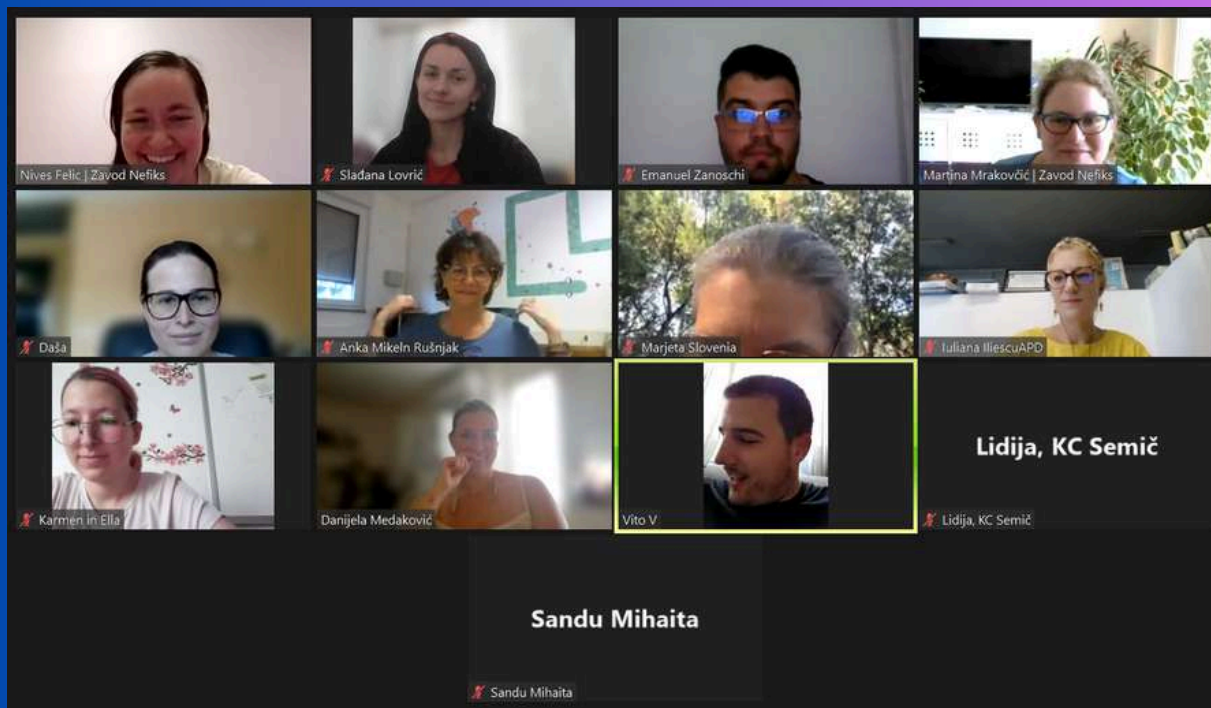

FINAL EVENT: You(th)App Online Roundtable with high EU officials

- Throughout the summer, the focus of the Moral Diplomat under the leadership of Slađana Lovrić was on the professional and targeted preparation of EU events with high-ranking EU officials. The strategic goal was to discuss the framework of youth work and youth-related policies and practices with experts from EU institutions and EU organisations and networks who are actively working for the benefit of the future of young people, encouraging and building them to become responsible leaders of the next generation.
- The coordination of the event preparation and the sensitive and complex implementation at a high level with five guest speakers and more than 70 participants actively working in the field came to life in a very professional yet friendly edition, despite numerous challenges.
- High-level events with EU officials always come with a last-minute change in the availability of guest speakers, so in the case of our roundtable, we had to give up the idea of accommodating the agenda of the Members of the European Parliament working ambitiously on youth-related files, due to their busy agenda at the start of new EU mandate and struggles to have them at the tables.
- The organisation of receiving valuable input and questions from registered participants provided us with a third dimension of active participation of young people and people working for and with young people and allowed us to reflect on their contribution during the You(th)App Online Roundtable, which was given in a 100% safe space (without names in front of the guest speakers and other participants), and be ready to comment on them.

The event was organised at the beginning of new EU mandate, during the Hungarian Presidency, upon EP and elections of the European Commissioners.

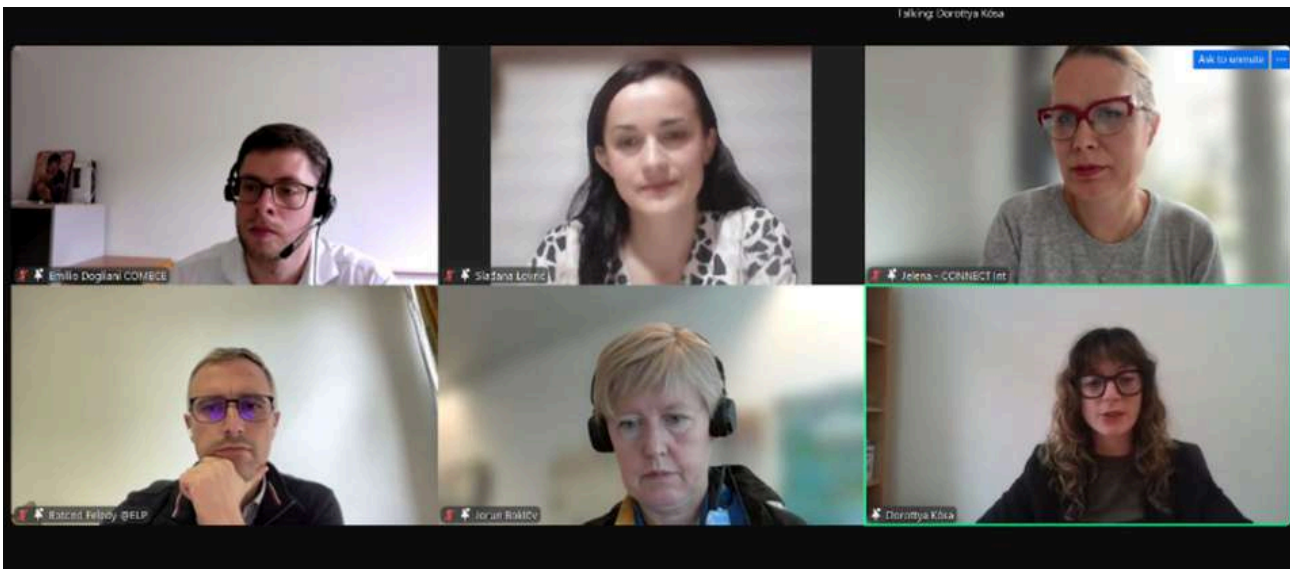
